I/We have read & understood all the terms & conditions governing the CA Business Edge Account. I/We understand that I/We have to maintain an Average Quarterly Balance of INR 10,000/- in the said account. I/We understand that maintenance of the stipulated Average Quarterly Balance shall entitle me/ us to the following benefits:

- 1) 50 Free Cheque Leaves per annum
- 2) Waiver of charges on NEFT/RTGS through Internet Banking
- 3) SMS Alerts
- 4) Free E-mail Account Statement
- 5) Waiver of charges on issuance of 10 PO/DD per month up to an amount of INR 1,00,000/-
- 6) RuPay Platinum Debit Card with Cash Withdrawal limit of INR 25,000/-, POS limit of INR 25,000/- and Ecom limit of INR 25,000/- (Card issuance charges waived)
- 7) Personal Accidental Death Insurance Cover on RuPay Platinum Debit Card of INR. 2 Lakhs \*\*
- 8) Unlimited transactions on all SVC Bank ATMs
- 9) 5 Free transactions per month on other Bank ATMs

- b) I/We also agree that if account is closed anytime between 15 Days to 1 year from the date of opening of the account, Bank shall charge a penalty of INR 450/-
- c) The Bank is at liberty to modify/change any of the aforesaid benefits at any point of time at its sole discretion
